Expressions of Interest

The Government of Afghanistan (GoA) through its National Rural Access Program (NRAP) has secured a grant from the World Bank (WB) as the cost of the Afghanistan Rural Access Project (ARAP) and intends to apply part of the proceeds for the community satisfaction survey of this project, thus, looking for the service of an **Individual National Consultant** to carry out the following scope of the assignment but not limited to:

1. Main Objectives

The main objective of the assignment is to measure the efficiency of Grievance Redress Mechanism (GRM), degree of Citizen Engagement (CE) in subproject implementation and construction work and level of their satisfaction with the availability and quality of roads.

To achieve the above the following three indicators should be calculated:

- Determine how and when beneficiaries, including SICs, are consulted about rural road route selection, and if local communities have a chance to review draft design for road;
- Determine how and when the affected families (male & female) are consulted about donation, compensation;
- Determine whether beneficiaries are being given full, accurate information about RPF-entitlement package, eligibility criteria & GRM.

2. General scope

This assignment will have 5 principal areas of work: 1) Formulating and finalizing Data collection strategy or Methodology 2) Data Collection 3) Data analysis; 4) Preparation of an analytical report in English; 5), Disseminate the report to main stakeholders (executing ministries, NCU, and WB), collect the possible comments and incorporate them to the report.

3. The consultant assignments summarized as but not limited to:

- Design/develop survey instruments/questionnaires to measure beneficiaries' satisfaction and use it to determine the overall rating of the current level of satisfaction;
- Conduct interviews and complete the questionnaires
- Analyse the collected data via statistical software, STATA, SPSS or any other relevant software
- Determine the quality of service delivery as perceived by the beneficiaries;
- Identify whether expectations are being met or otherwise;
- Identify gaps in service delivery;

- Identify the sources of beneficiaries' complaints/dissatisfaction in regard to service delivery;
- Incorporate in the analysis the result gathered from the beneficiaries' satisfaction survey from different events;
- Propose service improvement measures; and
- Prepare and deliver a comprehensive report detailing the methodology, findings, and recommendations from the assessment.
- Coverage and minimum sample size to be surveyed

4. Assignment Duration

Expected duration for the assignment is approximately two calendar months, or 60 days after signing the contract. The consultant will be based in Kabul with frequent travel to project sites. While in Kabul the Consultant will provide weekly updates to NCU on the progress of the assessment and preliminary findings as requested.

5. Key Qualification

The interested Consultant should possess the following competency:

- Master Degree in project management or relevant field;
- Minimum 5 years working experience in research design, methodology formulation and implementation
- Expertise in working in STATA, SPSS, or any other statistical software.
- Excellent Report Writing and computer skills both in English and one of National language.
- Experience in team/task leadership preferably in fragile states,
- Experience in data collection
- Familiarity with the World Bank's procurement principles,

Services are expected to start at mid of September 2020

Interested consultants must provide information indicating that they are qualified to perform the assignment (**Educational background, knowledge of research, conducting survey and description of similar assignments, experiences in similar conditions is required**).
